Administrative vs. Technical Completeness

- Administrative completeness:
 - Has the applicant submitted all the required <u>paperwork</u>?

- Technical completeness:
 - Has the applicant submitted all the required technical information?

• To be deemed a complete application for processing in NC, each application must be <u>both</u> <u>administratively and technically complete</u>



Administrative Requirements

- Submit all required application forms (see application matrix)
- Appropriately signed and filled out application forms
- Local zoning consistency determination
 - -- Facility in an area without zoning has different requirements
- Professional engineer (PE) seal, if required
- Number of copies
- Application fee
- Financial qualification or substantial compliance statement, if required



Technical Requirements

- Regulatory applicability and compliance
 - Discuss regulations that don't apply if it appears like it could
- Narrative of project or modification
- Process schematics and parameters
- Emissions information
 - -- Sample calculations
 - -- Source of emissions factors
- Modeling analysis, if required



PSD-only Requirements

- Best available control technology (BACT) analysis
- NAAQS modeling/source impact analysis
- Source information
- Additional impacts analysis
- Class I analysis, if applicable
- Pre-application meeting



Common Application Pitfalls

- Omitting discussion of regulatory applicability (or non-applicability) and compliance
- Inappropriate or missing signatures
- Missing local zoning consistency determination
- Omitting PE seal
- No supporting calculations
- Incorrect/undocumented emission factors
- Missing manufacturer specifications for all new equipment
- Not paying the required application fee



How to Improve Application Submittals

- Fill out each required form as specified in the NC DAQ application matrix for each application type
 - https://www.deq.nc.gov/about/divisions/air-quality/air-quality-permitting/modifying-or-applyingair-quality-permit/application-forms-air-quality-permit-constructoperate-non-title-vfacilities/required-air-permit-application-forms-matrix
- Fill out all forms <u>completely</u> (fill in as many blanks as possible!)
- Address zoning when constructing new sources and control devices
 - When in doubt, zoning is required
- Provide comprehensive discussion of regulatory applicability and compliance
- Provide emissions calculations spreadsheet upon application submittal



Regulatory Review Process Updates

- Session Law (S.L.) 2023-134; Section 12.11(a) revised North Carolina General Statute (NCGS) 143-215.108(d)(2): Control of source of air pollution; permits required
- Required NC Environmental Management Commission (EMC) to adopt rules that specify
 the times within which it must act upon applications for permits. EMC adopted
 amendments to several rules on March 13, 2025.
- Request for approval of State Implementation Plan (SIP) Revisions sent June 27, 2025; currently awaiting EPA approval. Effective on the first day of a month that is 60 days after the Secretary of DEQ certifies to the Revisor of Statutes that the EPA has approved the revised SIP.
- Therefore, amended rules are not effective until after EPA approval and 60 days notice.

15A NCAC 02Q .0525	Division sends written acknowledgment of receipt within 10 days	Division sends written acknowledgement of receipt within 10 days, also noting whether the application is accepted for processing
	Division determines completeness within 60 days (not applicable to minor modifications)	Division must notify the applicant of completeness within 60 days (not applicable to minor modifications)
15A NCAC 02Q .0515 15A NCAC 02Q .0525	Processing clock stops after written request for additional information is made; restarts after information received	For minor/significant modifications, Division must take final action within 90/270 calendar days of complete application submittal (i.e., clock does not stop once application deemed complete)

Regulatory Review Process Updates (02Q.0300)

Rule	Current Requirement	Updated Requirement
15A NCAC 02Q .0303	-	New definition for "complete application"
15A NCAC 02Q .0312	Division sends written acknowledgment of receipt within 10 days	Division sends written acknowledgement of receipt within 10 days, also noting whether the application is accepted for processing
	Division determines completeness within 45 days	Division must notify applicant of completeness within 45 days.
15A NCAC 02Q .0312	Processing clock stops after written request for additional information is made; restarts after information received	For modifications, Division must take final action within 90 calendar days of complete application submittal (i.e., clock does not stop once application deemed complete)
